CLARIFYING AND MODIFYING THE JUNE
1, 2026 ORDER GRANTING PRELIMINARY
APPROVAL;**

1 **~~[PROPOSED]~~ ORDER**

3 The Court finds good cause to approve the Second Amended Settlement Agreement. The Court's
4 June 1, 2026 Order Granting Preliminary Approval remains in full force and effect. All references
5 in that Order to the Settlement Agreement shall be deemed references to the Second Amended
6 Settlement Agreement. The Court's findings regarding preliminary approval, provisional
7 certification, appointment of Class Counsel, appointment of the Settlement Administrator,
8 approval of notice procedures, and all other findings and rulings remain unchanged. The PAGA
9 Period is corrected to January 11, 2022 through July 11, 2025. The revised Notice is approved.
10 The deadlines in Paragraphs 10 through 14 of the June 1, 2026 Order are modified as follows:

11 *Deadline for Defendant to provide class data to the Settlement Administrator:*

12 June 18, 2026;

13 *Deadline for mailing the Class Notice:*

14 July 2, 2026;

15 *Deadline for class members to submit objections, requests for exclusion, and workweek disputes:*

16 September 1, 2026;

17 *Deadline for filing motions for final approval, attorneys' fees and costs, and service awards:*

18 July 31, 2026;

19 *Deadline for filing responses to objections and for the Settlement Administrator to provide its*
20 *final report:*

21 September 18, 2026;

22 *Final Approval Hearing:*

23 October 2, 2026, at 9:00 a.m., in Department 6, or such other date and time as the Court may
24 order.

25 Except as expressly modified by the Court's order on this Stipulation, all provisions of the
26 June 1, 2026 Order Granting Preliminary Approval of Class Action and PAGA Settlement
27 shall remain unchanged and in full force and effect.

1 In the alternative, should the Court decline to modify the schedule set forth above, the
2 Parties respectfully request that the Court nevertheless approve the Second Amended
3 Settlement Agreement and revised Notice and order that all references in the June 1, 2026
4 Preliminary Approval Order to the Settlement Agreement shall be deemed references to the
5 Second Amended Settlement Agreement.

6 Except as expressly modified herein, the June 1, 2026 Order remains unchanged and in full force
7 and effect.
